Purchaser agrees to the following:

A non-refundable "Reservation Fee" of \$500.00 has been received from Purchaser to be applied towards the purchase price of the above-described kitten. The Purchaser must pay the balance* due before the kitten is released. *This payment must be made in cash, money order or cashiers check at or before pickup. Personal check can only be accepted when received by the Breeder no less than 7 business days prior to pickup.*

The kitten will not be released to the new owner until full balance is paid, including shipping if applicable.

**The purpose of the "Reservation Fee" is to insure the Purchaser's serious intent to purchase a Bengal kitten. It is not refundable should the Purchaser, for any reason, change his/her mind about purchasing the kitten prior to the initial veterinarian examination described in the Sale Contract, no exceptions. (Purchaser can defer choosing a kitten to a future litter if the available kittens are not quite the right match for the Purchaser, or if in the best interest of the kitten, or another time frame would be more suitable.)

The cost of the kitten is guaranteed for least 1 year or until the first deferral, whichever is longest. At that point, the price may be adjusted to reflect the then current price. This place in queue is being reserved for the Purchaser exclusively and will not be sold to any other buyer. The Breeder is also committing to the Purchaser to continue to communicate and update the Purchaser on the kitten's progress with verbal, written and photographic information. A breech of contract, either verbal, written or through neglect or avoidance to communicate, on Purchaser's part can jeopardize the chance of finding the kitten represented by your place in queue a new home as quickly as possible. For this reason, "Reservation Fees" are not refundable; to insure Purchaser's commitment to purchase above a kitten, pay the balance due as indicated above and to accept delivery as of <u>TBD</u>. After this date all rights to and moneys for this kitten are forfeited.**

The above "Reservation Fee" will be refunded to the Purchaser if the Breeder fails to make available the above said kitten/cat to Purchaser. However, the Breeder reserves the option to offer a replacement kitten/cat and Purchaser is entitled to accept or decline. Kittens are generally ready to go to new homes at about 3 months of age. Arrangements can be made should the buyer request that the kitten be held for a longer period of time.

Please note neuter/spay is the responsibility of Purchaser.

This document will be considered legally binding between the Purchaser and Breeder. A facsimile or emailed copy of this signed agreement shall be enforceable as an original if the original contract is lost, destroyed or otherwise unavailable.
